## Central Air Conditioner Rebate Form

All rebates will be applied as a credit to electric statements

To apply for your rebate, please carefully read the information below.

**Then complete the 2018 Rebate Request Form.**

### Rebate Requirements:

- Central Air Conditioner Unit must be qualified SEER (Seasonal Energy Efficiency Rating) of 16 or greater.
- Must be installed by a licensed Heating, Ventilation and Air Conditioning (HVAC) contractor. All necessary permits must be obtained prior to installation.
- A rebate request form must be completed and submitted to FKEC along with proof of purchase within sixty (60) days of installation. The member must provide the contractor's invoice or paid receipt, including the member's name, address of installation, date of sale and SEER rating.
- Onsite verification of installation is required.
- Please refer to the Energy Efficiency Rebate Policy below for complete details.

### Energy Efficiency Rebate Policy:

#### Section 1. Overview

FKEC offers conditional rebates to qualifying members as an incentive to install "Qualifying Energy Efficient Equipment". Members benefit from Qualifying Energy Efficient Equipment through utility bill savings and sound environmental stewardship.

#### Section 2. Program Eligibility Criteria and Requirements

The following criteria and requirements must be met for a member to be deemed eligible for a rebate.

##### 2.01. Eligible Participants

- Only residential retail electric members of record may qualify for a rebate.
- Rebates are valid only on existing residential homes.
- Rebates do not apply to new construction homes.
- The Qualifying Energy Efficient Equipment must be located at the member's primary residence, and within FKEC's service territory, and must receive retail electric service from FKEC.

##### 2.02. Qualifying Energy Efficient Equipment

- The following provides the equipment and/or products that qualify for a rebate; the rebate amount; and the limit on the number of rebates per member:
  - Central Air Conditioner
    - Rebate Amount: 30% or up to \$500.00

### Energy Efficiency Rebate Policy - *continued*

#### 2.02.1. Application

- An application for a rebate must be completed by the member and approved by FKEC.
- A copy of the proof of purchase by member from an established vendor must be attached and mailed to FKEC within 60 days of installation. The proof of purchase must include the members name, address, and date of purchase. Additional information specific to the type of rebate being sought may be required.

#### 2.03. Additional Terms

- Equipment must be installed in accordance with the manufacturer's recommendations.
- Rebates will not exceed member's purchase or installation price.
- Equipment must be installed prior to issuance of a rebate.
- Onsite verification of installation is required prior to issuing a rebate.
- FKEC reserves the right to:
  - Withhold credit of any rebate until any identified problems with the application are resolved.
  - Terminate this rebate in whole or in part due to the recipient's failure to fulfill the terms and conditions in this document, or due to non-appropriation of necessary funds.
  - Alter or cancel the rebate program at any time and without notice to member.
- All rebates are subject to funding availability. FKEC may cancel a rebate at any time prior to payment, without notice, due to lack of available funds.
- Rebates may take up to 4 weeks to process.
- A credit for the amount of the rebate will be issued to the member of record.

#### 2.04. Limit of Liability; Indemnification

- In no way shall FKEC be liable for, and Member hereby agrees to indemnify, defend and hold harmless FKEC, its subsidiaries or affiliates, and their respective employees, officers and directors, from and against any and all liability, loss, damage, cost or expense, including attorney's fees, that may be caused by, due to, occasioned by, or otherwise arising out of the installation, operation, miss-operation, or use of Member's Qualifying Energy Efficient Equipment.
- Member acknowledges and agrees that in no event shall any statement, representation, or lack thereof, either express or implied, by FKEC, relieve the Member of exclusive responsibility for the Member's system. Specifically, FKEC's approval of the rebate application, credit of the rebate, or any FKEC inspection of the Qualifying Energy Efficient Equipment shall not be construed as confirming or endorsing the system design or its operating or maintenance procedures nor as a warranty or guarantee as to the safety, reliability, or durability of the Qualifying Energy Efficient Equipment.

#### 2.05. Renewable Energy Credits; Green Attributes

- By participating in this program, customer agrees that FKEC shall have the sole right to obtain and retain ownership of, and to qualify for and receive the full benefit of, any and all existing and future credits, certificates, benefits, environmental attributes, emissions reductions, offsets and/or allowances, however entitled, attributable to the purchase, installation and/or operation of the Qualifying Energy Efficient Equipment.
